Registration Guidelines

Be sure the entire registration form is filled out! If any registration form is incomplete, all forms may be delayed. Verify that you have—

- Parent's signature and parent's initials for "Standards Regarding Conduct"
- Pastor's signature
- Notary seal (on Counselor Forms)
- Social Security numbers
- Medical information
- T-shirt size
- **PROOF OF BACKGROUND CHECK ON ALL COUNSELORS AND CAMP STAFF MUST ACCOMPANY REGISTRATION** (See Safe Sanctuary Requirements below.)

Final deadline is June 1, 2007. No registrations will be accepted after this date. However, your church may substitute campers of the same sex and grade level. For example, if you have a male 4-5th grader who cannot attend, you may send a different male 4-5th grader in their place.

Counselor Ratios

If you are sending any male campers, you must send male counselors. If you are sending any female campers, you must send female counselors. The camper to counselor ratio is 4 youth to 1 adult. Persons serving in positions other than counselors **DO** count toward your 4:1 ratio.

Counselors and Camp Staff Are REQUIRED to Arrive on Sunday

Make sure your counselors and camp staff know they need to arrive in camp on Sunday, July 19th. Activities will include getting settled in the room, dinner, Safe Sanctuary Training, worship and individual camp meetings.

6:30 p.m. Safe Sanctuary Video (St. Luke's)

If you must bring campers with you, their meal cost will be \$6 for Sunday evening and \$5 for Monday breakfast. No exceptions.

Safe Sanctuary Requirements

All counselors and camp staff are required to have their backgrounds checked and pass the online required State test prior to arrival. Background checks are required annually. Be sure that your certification of the reference & background check has been sent in to Dan Ramsey, 5215 Main Street, Houston, TX 77002.

All counselors and camp staff shall participate in the Texas Annual Conference Safe Sanctuary Training at the beginning of District Camp on Sunday evening.

Leaving Camp

Lunch for camp participants will be provided on Friday. Campers may be picked up following lunch, beginning at 12:30 p.m.

Due to child safety guidelines, each child must be checked out by their camp director to the appropriate adult at their grade level camp. Please make sure that parents and adult drivers know that we cannot send campers to another location to be picked up. Adults will be required to show a valid driver's license.

Any child who leaves prior to 12:30 p.m. on Friday will need to complete Early Release Procedures. This will require a valid driver's license, a Letter of Release and the appropriate Lakeview forms. No child will be released prior to 12:30 p.m. on Friday except to a parent or legal guardian.

Statement of Nondiscrimination

Registration and participation in all of Lakeview's programs are the same for everyone without regard to race, color, religion, age, gender, disability, national origin or political belief. However, due to the nature of the activities of summer camp, any camper with special needs must be accompanied by an adult who is familiar with them and can assist them at all times. This adult does not count toward the adult/camper ratio from your church. Make sure that the counselor's form has the camper's name and grade level. Make sure that the camper's form has the adult counselor's name.
